

## RIGHT RELATIONS, HERITAGE OF THE FUTURE

*Editor's note: The following paper was translated from Portuguese by Dr. Jayme Treiger*

It is interesting to trace a parallel between the Tibetan's teachings and what Morin, the French philosopher, says when focusing the crisis of the present time:

While the Tibetan explains that it is partially resultant of the transitional period between the 6<sup>th</sup> and the 7<sup>th</sup> Rays of influence, with the predominance of the emotional nature of men's personalities-- which gave way to the devotional and idealistic attitudes of men in the last 20 centuries, Morin uses almost the same words to say how the last 20 centuries were characterized by a tendency to devotion of myths and personalities, to idealism and ideologies.

This vision of life and society resulted in a blind and unilateral, poorly formed paradigm on ethics, which is no more acceptable.

Agni Yoga Teachings say that, "What we observe is that the lack of ethics of the present time which is particularly linked to the absence of ethics of the future", and Francis Ost says that "Selfishness is clearly linked to the egoism observed in the incoming generations; however, when you do not care of the poor nations, the forgetfulness of the future generations will be the other face of the same coin."

Federic Mayor, former Director of UNESCO, says that "if we do not act in time, the future generations will not have any time to act, as they will run the risk of becoming prisoners of the processes which include demographic growth, degradation of the environment and the social differences between North and South.

Therefore, if an ethics of the future is to be considered, it should be most important to

recover the public space through authentic debates, opening the way to a new model of human relationship. On the other hand, quoting the Tibetan once again, the modern time Initiation should be based on Education and no more on the old fashioned style of keeping secrets in the mysteries of the temples.

According to Jacques Delon, Education should be based on 4 pillars:

***Learning how to know***

***Learning how to do***

***Learning how to be***

***Learning how to live together***

These pillars should be basic to any democratic experiment and, for that, the logic of exclusion and the social apartheid should not be accepted, while an ethics of discussion should be assured.

Another point to be considered is the development of a new concept of heritage. In the past, Heritage was a mere legacy of the past; it was an element of definition of a kind of relationship with the Ego, through the transmission of an ancestral good.

Nowadays, Heritage comprises everything related to culture and of nature; it will not be limited to the physical heritage any longer; on the contrary, it will include the immaterial and symbolic heritage, the genetic and ethical heritage and also... "it became an element of definition for the relationship with our neighbors—neighbors in the space, once heritage is now being understood as the common heritage of the whole of mankind.

If we include time to space, it becomes a focus of ethical reflex and creates a human responsibility regarding the future generations. Let us remember that humanity is trans-historic, and thus, the past, present and future generations will always be inter-connected.

It is this linkage that, according to Remond-Gouillon, “gives the opportunity of forming a dynamic sense of solidarity among generations, giving a significance to the perpetuation of mankind, and the human beings a reason why to live.

The authors of the present time already recognize that thoughts and actions are definitely reciprocally linked as they now reproduce the PASCAL’s paradox: “Let us strive to think correctly—this is the principle of morality.”

However, the 20th Century also induced to focusing only on what was urgent and immediate and blind to the relationship that linked past, present and future. Only what could be measured was respected; and joy, love, suffering were automatically abandoned and despised.

The other two elements of ethical value were also eliminated—responsibility and solidarity.

In the meantime, the present time crisis is forcing us to incorporate much higher levels of organization; the mystical thought is being renewed and those who were mystical are now also becoming practical.

A new paradigm is growing in importance—the paradigm of uncertainty -- and two other paradigms are to be connected with it: **social responsibility and solidarity**. Through them the moral obligation will become ethics. They were foreseen during the Eco Summit Conference of Rio, in 1992.

It is clear that for all this we must learn the correct way of thinking. And this, in its turn, leads us to despise what is happening in the main bureaucratic organizations, where the individual dissociates himself of everything, because he is so non-responsible—and irresponsible—for anything, and on account of that he loses his “status” as a citizen and becomes, as Elliot puts it, “a handful of dust, before the numeric dust of quantification!”

PASCAL’s paradox opens the way towards a new thought, which connects all parts to the whole—they become **whole**, restoring the value of the individual and offering us all a chance of reaching the consciousness of the complexity of what is real and human, giving us a chance of becoming really human beings, including in it the will of safeguarding the diversity of cultures.

***Complexity makes us human beings: it gives us opportunity for recognizing and witnessing the will of safeguarding the diversity of cultures.***

The complexity of the real man is the opposite to what is called the

“globalization of economy”. In my opinion, this globalization should be better called the Anti-Christ of the Apocalypse, so opposite it is to the principles and objectives if compared to the Teachings of the Nazarene. As a matter of fact, complexity makes us human beings: it gives us opportunity for recognizing and witnessing the will of safeguarding the diversity of cultures. The way to protect ourselves from misdoing during this phase of uncertainty is to use firmly the Right Thought and also use the Right Speech in the Right Time—which will lead us to adapt ourselves to the circumstances of the moment, using, thus, the 3<sup>rd</sup> Ray of Influence, which is, indeed, one of our goals to put into practice.

The problem we face is that, again quoting Morin, “You cannot reform the institutions without reforming those who lead the institutions.” And this brings us to a new point:

“Who is going to teach the teachers and scholars?”

Bindé proposed that we should learn again how to think, even when without teachers. It is time of practicing what Piaget says, “one must learn how to do, by doing it”.

Jacques Delon synthesized Buda’s Noble Octuple Path when he proposes that we should learn how to be able to live together and in harmony.

In the right moment, teaches the Tibetan, the Spirit of Peace will vitalize our capability to give answer to the Will of God, our capability of being stimulated and influenced by the Spiritual Hierarchy, whose basic purpose is to bring peace to Earth.

### ***Establishing Right Human Relations***

What is Peace? “It is essentially the establishment of right human relations, of synthetic relationship, with the resultant cooperation and right interchange among human beings and an illuminated understanding of the Will of God, as it affects humanity and fulfills its Divine intent.”

To open this Way, Christ, for the first time in the planetary history, promoted a contact among the Spiritual Hierarchy, Humanity, Shamballa and the Spirit of Peace, and—focusing the 1st Aspect of the Divine Presence— He said, “Father, may Thy Will be done, and not mine.”

And when He was asked about the practical way of doing it, he synthesized the fundamentals of the Jewish Law in 2 commandments: “Love God, thy Father, above everything else and thy neighbor as yourself.”

The Scholars say that the Jewish tradition teaches that to be a good Jew, one should keep in mind 3 postulates:

***1- We are responsible, each one for the other ones.***

***2- And you will love your neighbor as yourself.***

***3- If not now, when, then?***

And what should we expect from humanity in this search for the Heritage of the Future?

Again Morya says in Agni Yoga that “People should listen to the word at-one-ment the same way as they speak about the daily bread. In the right moment, each word about at-one-ment will be literally applied.”

And also, “In times of great decisions it is most important to participate in the Concentration of the Master, striving to Them with all our strength, forgetting everything that is around or behind us, day and night, in the heat or in cold weather, during a short or a long time... This strife is definitely useful because it creates currents in the space, in harmony with the special currents of the Hierarchy of Spiritual Masters. If such beneficial thoughts could be sent simultaneously from several countries, what powerful dischargers they would generate!”

The quotations of some of the best known educators in the world are good to show how the Teachings of the Masters are already touching their minds, opening the way for many to reach the new paradigms. As time and space are being identified as parts of the world glamour, we are led to the Agni Yoga Teaching that we should start now, because now is the time. The understanding that we are trans-historical; that past, present and future are definitely interlinked, leads us to the evidence that the heritage of the future starts in the right human relationship of the present.

## Sorting It Out

**“Revelation will come when the world disciples and initiates have perfected the art of revelation.” *The Rays and The Initiations* P. 300**

The subject of this talk has to do with the art of revelation. Revelation is the art of making it possible for persons to see, or on a higher plane, to understand Truth, that which is. Before we begin, there are a couple of things that need to be understood about the service of revelation:

First, one must, if one is to succeed, realize at the outset that the artist of revelation is a warrior. Revelation of truth is the most dangerous service there is. Next, although the creative efforts of the artists, poets, painters, sculptors and so forth reveal truth, the making of art is not the only way to revelation. This is good because most disciples and initiates are not artists. They are simply men and women like most of us, and for us there are other aspects to the art of revelation which we can learn to employ and thus join the ranks of the warrior revealers.

We are well aware of the fact that The Forces of Retrogression are not at all interested in having humans see or understand the Plan, and that they spend an enormous amount of time and energy on creating and maintaining obfuscating veils between their efforts and the reality of the Plan. In this paper I am dealing with an aspect of the art of revelation that has to do with what I simply refer to as veil clearing.

Being disciples, we have been trained to see the situations, issues and challenges which we contact in our daily lives in terms of a world whole, and we search for their meaning in terms of their group significance. As D.K. says, “This serves to decentralize [the disciple] and to

convey into his consciousness some aspect of that larger whole, and this in its turn contributes to the expansion of the consciousness of humanity as a whole.” *The Rays and The Initiations* P.37 So, although many of the examples and situations I cite in this talk are drawn from political and economic events that have occurred in the U. S., these events do have a worldwide impact, and the consciousness that has driven and is driving them constitutes a worldwide condition, a condition, I might add, that resembles acute paranoid schizophrenia. As such this condition has produced similar Plan veiling events all over the world.

Obfuscation or the creation of veils, that is the placing of an illusive barrier between one’s self and reality, besides being a common pathology of the schizophrenic condition, is of course, one of the oldest and best used tools in the kit of the Forces of Darkness. And one of their favorite ways to hide or veil their activities, that is to generate these

illusionary screens, is through the deliberate use of the concepts of light. They adopt these concepts to cloak and hide their dark and devious plans, and in addition, they confuse and cloud peoples minds with the Great Lie. Examples abound:

In the early nineteen nineties the elected U.S. President Bush was preparing the first stage of what now seems to be a long planned agenda of the Neo-Cons to establish a corporate controlled world hegemony. Bush said he was going to establish a “New World Order”. As far as I

know, the phrase “New World Order” was coined by D.K and Alice Bailey. The initial use of the term appears in a discussion of the work of the New Group of World Servers in *Esoteric Psychology II*, first printed in 1942.

“The New World Order” was a term coined by Alice Bailey and D.K. to describe the coming Aquarian dispensation. Bush used this Light generated term to cloak the plan to create a corporate controlled world hegemony in an illusory aura of goodness. In his public and consequently widely publicized use of this term, Bush also co-opted or appropriated the concept of A New World Order so that its use by the Forces of Light would be confusing and misunderstood.

In the regime of the present un-elected U.S. President Bush this tool of co-opting or appropriating ideas of light to cloak schemes of darkness is all but being worn out. Thus we have the *No Child Left Behind Act* of 2001 which cuts and or eliminates numerous budgets for essential programs for children at all levels of the public educational systems. Another example, a slight variation of the theme of this kind of manipulation, can be seen in leaving totally unfunded *The Healthy and High Performance Schools Act* of 2001.

To obscure the assault being made on the environment by these forces, we have actions being taken or proposed under the names of the *Clean Air* and *Clean Water* acts. These proposals and actions turn out, on inspection, to promote just the opposite of clean water or air. The following excerpt from an extensive analysis of Bush’s actions regarding clean water will illustrate.

“Campaign promises and numerous public pronouncements to the contrary, since the first weeks of his administration, President George W.

Bush has taken steps to systematically undermine or repeal the nation’s most important safeguards that protect clean water. He has weakened or proposed to weaken programs that maintain water quality, cut huge sums for funding for clean water protections, scaled-back enforcement efforts, and even proposed eliminating all federal Clean Water Act protections from the majority of the nation’s streams, wetlands and other waters. Individually, each of these measures means dirtier water for many Americans. ***Taken together, these actions constitute the most concerted effort to dismantle the Clean Water Act since the law was enacted over three decades ago.***”

One other example: Under the guise of “forest fire prevention”, the Bush Administration's Forest Service has proposed the "mechanical thinning of conifer" in California’s Sequoia National Monument. “Mechanical thinning of conifer” is the euphemism used to obfuscate the plan to allow logging in these ancient forests. The Sequoia National Monument is home to some of the world's tallest and oldest trees, reaching ages of 3,200 years. It is worth noting that these trees are probably the oldest living things on the dense physical plane on the planet. They reached this advanced age with no mechanical thinning or help of any other kind from the human kingdom. Perhaps we should be studying them to discover the secret of their longevity rather than planning to cut them down in the name of protecting them.

The use of language, thoughtforms and ideas in this manner is literally as old as the hills. Machiavelli’s *The Prince* written in 1513 is an example of an early handbook on such manipulation for the purpose of gaining and keeping power. And of course, this kind of

manipulation is commonplace in all works that are engendered and implemented by the Forces of Retrogression. Witness the use of the idea of Joy by the Black Lodge in the Second World War: In speaking essentially about the coming New World Order D.K. said, “The cup of sorrow and the agony of the Cross are well-nigh finished. Joy and strength will take their place. Instead of sorrow we shall have a joy which will work out in happiness and lead eventually to bliss. We shall have a strength which will know naught but victory and will not recognize disaster. Even the Black Lodge knew of this change in the mode of salvation, and hastily founded its groups of youths, banded together by the motto ‘joy through strength and strength through joy.’” *The Rays and The Initiations P. 234*

But Humanity is in the process of generating a New World Order based on a set of Laws and Principles very different than those that impulse the work of the Dark Side. This is clear to anyone who studies the evolution of consciousness. It is startlingly and painfully clear to those who are aligned with the Forces of Darkness and the Old World Order because it signifies the end of the Kali Yuga and their dominance on this planet. Thus we have this all-out attempt by the Forces of Retrogression to preempt and obfuscate the vision of the coming New World Order by claiming that their plan for the geopolitical, economic, environmental and social world is the one for which we all have been waiting, for these many years. Anything but new, this planned world hegemony of the Forces of Retrogression is rooted very deeply in the ancient evils of past millenniums.

The Old World Order has been controlling or at least attempting to control the evolution of humanity for many thousands of years. Esotericists refer to this period as the Kali Yuga. According to the Ageless Wisdom, this

system was put in place as a result of the rulers of old Atlantis choosing the path of materiality over the path of spirituality. This choice, as the Ageless Wisdom tells us, caused not only the disappearance of Atlantis, but also—because of the withdrawal of the Spiritual Hierarchy from participation in the dense physical affairs of men and the consequent loss of so much knowledge—major adjustments and changes in all aspects of civilization and culture in the world’s systems of day to day living.

Ironically, or perhaps indicative of the nature of the cycles, the crux of the present world crisis seems to be focused in the territory we call The United States which was the center of Old Atlantis (*Destiny of the Nations P. 46*) where the choices of the then rulers to place the material aspect over the spiritual started the Kali Yuga. ***It does appear that the present time, that these days during which we are now living are, once again, the “end days”, the days of decision for humanity. The situation today, in terms of the essential choices, is very much like the previous one.***

As D. K. points out, “...I would remind you of a most important point and that is that the masses of the people—the middle classes, the bourgeoisie and the proletariat (I use these words in their general sense and simply because of their significance and meaning)—are still victims of authority, of control, and remain relatively unthinking and childlike. This means that the true conflict is between a small minority to whom the issues are illuminatingly clear and who have definitely ranged themselves on one side or other of the embattled forces. A mere handful of men, the direct descendants or rather the reincarnations of the leaders in the ancient Atlantean conflict, are now on earth, directing the forces of light or of darkness and bringing into being a direct line-up of millions of men whose will is that of their leaders.

The lines of cleavage have grown steadily until now they can be expressed in terms of a humanity which is oriented towards the higher spiritual and altruistic values and whose keynotes are sacrifice, group good and world understanding, and those whose focus is predominantly material and whose aims are selfish, animated by ambition and the spirit of acquisition.” *The Externalization of the Hierarchy* P. 126

In the above quote, D.K. was referring to the world situation as it was at the onset of the Second World War. However, in real terms, that is in terms of consciousness, very little has changed. If anything, the situation regarding the awareness of the people referenced in the above quote has diminished. The Forces of Retrogression are, naturally, doing everything in their considerable power to obfuscate these lines of cleavage and thus to confuse, terrorize and deflect the attention of “the middle classes, the bourgeoisie and the proletariat”, the basically good natured men and women of the world from the Real issues of the times. To understand the power and the success of the Retrogressive Forces it is only necessary to look at the numbers of persons who, each week, spend their time and money pursuing sports: football, baseball and other such basically diversionary activities, and who are ignorant even of who their representatives are let alone what they are doing.

So, we come back, once again to the question, What can we, we who see ourselves as disciples, as workers and warriors in this eternal struggle, what can we do?

The answer of course is, “...for hierarchical workers to reveal with greater emphasis the fact of the Hierarchy. This—if done on a large scale and through proper organization—will destroy on a large scale the present world structure in

the field of religion, of economics, and of politics; it is already doing so. An increase of pressure on the part of all who recognize the factual nature of the inner subjective kingdom of God, will produce amazing results. This kingdom, through its major power (a quality of synthesis, could you but realize it), is gathering together into itself men and women out of every nation and out of all parts of the Earth. It is absorbing them into itself not because they are orthodox or religious in the generally accepted sense of the term, but because of *their quality*. Simultaneously, as their numbers increase, a reverse movement is taking place. Men are moving outward on to the physical plane, and doing this as a group in order to prove the factual nature of the world of unity into which they have succeeded in penetrating. They, therefore, are demonstrating oneness and synthesis in such a simple way that men everywhere can grasp it. The New Group of World Servers is the vanguard of the kingdom of God, the living proof of the existence of the world of spiritual Oneness. *The Rays and The Initiations* P 300, 301

One of the very best ways we have of revealing the Hierarchy is to make as clear as we can the **lines of cleavage** which exist between the forces of Light and the Dark forces. We need to understand what these basic differences are. Then, we need to forcefully and clearly enunciate these lines in everything we do as we go about our daily lives, thus, “making public the already existent Kingdom of God.” *The Reappearance of the Christ* P. 163.

Actually the differences break out in a couple of sets of principles and laws. So, to help with the task, as an aid in the effort to clear the field of the obscuring clouds of terror, glamour and illusion which the Forces of Retrogression are busily generating with every breath, we thought it would be good if we had a simple guide that would help us sort things out, a small outline

that would simply lay out the principle distortions upon which the Old World Order has been based and then compare them to the Principles of Light which are meant to be the basic building blocks of the New World Order.

We have, therefore, provided the following guide for the disciple in making the trek

through the often bewildering wilderness of glamour and illusion of The Old World Order toward the clarity and joy of The New World Order which will eventually reveal the Citadel of Light wherein waits the One Initiator, not just for the individual disciple but for the Disciple Humanity.

### *A Revealer's Guide*

#### ***Preface:***

*This little guide lays out the basic laws and principles upon which the Old and New World Orders have been constructed. The Guide will be most helpful in the hierarchical worker's effort to both discriminate between the Darkness and the Light and between the appearances of reality and Reality and to communicate or translate these basic differences into his environment through his daily living.*

#### ***The Principle Concepts of The Old World Order:***

*Note: The following compilation of basic concepts that govern and direct the efforts of the Dark side flow from the basic assertion of materialism that reality begins and ends with the dense physical plane. This is the basic Lie or distortion upon which the entire Great Illusion is constructed. This compilation is not meant to be exhaustive or exclusive, and it is not the only way these concepts can be formulated. It is simply meant to give a set of guidelines which the worker can use to identify the veils and perhaps, through destroying them, reveal what they are hiding.*

#### **Survival of the Fittest.**

Life is a continual struggle to the death for limited resources in which the fit survive, and the weak or unfit die.

#### **Might Makes Right.**

This denies the concept of human freedom and leads to the law of The Divine Right of Kings. It establishes a Hierarchy of exclusivity and privilege based on the ability to subjugate and dominate by force of one kind or another those under one or designated as less fit than one. The idea of individual freedom, of the right of an individual to make decisions regarding his/her own life has no place in this vision.

#### **The Ends Justify the Means**

This leads to the rule that any method used to gain and or maintain power is O.K. as long as it is for the purpose of gaining and or maintaining power.

#### **Ownership of Property Indicates Personal Value and Power**

Those who have power have the exclusive right to own/possess material wealth of all kinds including food and water. This is a self-evident truth because the powerful have the goods. In the

hierarchy of exclusivity, one's place is indicated by the amount of material goods and personal power one has amassed and can control.

## **All Can Be Owned**

Nothing exists outside of the material paradigm. Nothing is spiritual or sacred or non-material. Therefore, all that is in physical existence, including human beings, can be seen as potential property. In addition to justifying slavery, this law leads to the attitude that nature, the environment, the resources of the planet exist for the personal satisfaction, enjoyment and desires of those powerful enough to gain and hold control over them.

### ***The Laws and Principles of the New World Order***

***Note: The following compilation of the laws and principles that govern and direct the efforts of the Forces of Light flow from the basic assertions of The Ageless Wisdom that all is Life, and that Life is without beginning or end, that the three worlds of our material existence are but the dense precipitation of Love and Wisdom and Power, that the Universe is one harmonic whole, incomprehensible by present human intelligence, within whose Beauty we live and move and have our various beings.***

***The following Principles and Laws are drawn from the Teachings of Djwhal Khul. (Discipleship in the New Age Vol. II P.237) This list is not meant to be exhaustive or exclusive. It is not the only way these Principles and Laws can be formulated. It is meant simply to give a set of guidelines which the worker can use in his or her effort to reveal the Truth which lies behind the veils of distortion.***

## **The Principle of Essential Divinity**

In *The Bhagavad Gita*, Krishna says to Arjuna "Having pervaded the entire universe with a fragment of myself, I remain." This principle signifies the dualistic nature of Life, Spirit and Matter. It indicates that every form in the universe has at its core a spark of divinity, that it is in this sense a living sacred being. This is the basic principle that animates and impulses all thought and action of the hierarchical worker.

## **The Principle of Goodwill**
